WORKPLACE SAFETY AND HEALTH PROTECTION

At KRAIBURG TPE, safety is a top priority. It is the responsibility of management, as well as every employee, to take all reasonable safety precautions and to protect and ensure the safety and well-being of others. Every employee must understand and follow safety regulations set forth by the company, and be proactive in reporting any hazard he or she might observe.

Risk assessments of the workplace are conducted to ensure all administrative, engineering and PPE controls are in place to minimize the risk of personal injury and that the overall health and safety of every employee is maintained.

Support from external safety and environmental consultants are also utilized to ensure compliance to all local, state and federal requirements.





EMPLOYEE WELLNESS

In 2019 KRAIBURG TPE Corporation held its first Health and Wellness day. This event was coordinated with the focus being the health and wellness of our KTU employees. Local vendors participated in the event providing information on fitness, healthy eating, and medical screenings.





NOISE PROTECTION

Noise exposure in the production area is monitored to follow federal regulations. All operations employees are administered an annual hearing test to evaluate their hearing. Internal noise testing is conducted to evaluate the noise generated from manufacturing equipment. Installation of noise abatement curtains has aided in reducing the noise level throughout operations.

FIRE PROTECTION / EMERGENCY MANAGEMENT

We have established a contingency and emergency response plan to manage situations during an emergency. Our first responder team is trained in handling emergency situations such as CPR, AED, first aid and fire extinguishing. Periodic drills are conducted to ensure that the plan is effective.

ENVIRONMENTAL ACCIDENTS / ENVIRONMENTAL ASPECTS

There were no environmental accidents with environmental effects in 2019. Annually we conduct an environmental aspects and impacts analysis which is used as the foundation of our environmental program.

WASTE

A main goal of the EMS is the reduction of waste and emissions. Waste disposal is regulated through local, state and federal guidelines. Alternative handling of byproducts from production are evaluated for the potential to re-use or recycle with the last option being disposal. Local waste disposal companies are used to properly dispose of waste following all local, state and federal regulations.




GREEN ENERGY

Annually KRAIBURG TPE Corporation purchases Renewable Energy Certificate (REC) as part of our sustainability efforts. The annual purchase guarantees that an equal amount of renewable energy is delivered to the electric grid and avoidance of carbon dioxide emissions.







RECYCLING

A key aspect to our EMS is that instead of disposing TPE, our products are recycled. Products such as returned goods, production waste and obsolete materials are evaluated for recycling opportunities internally and externally.
